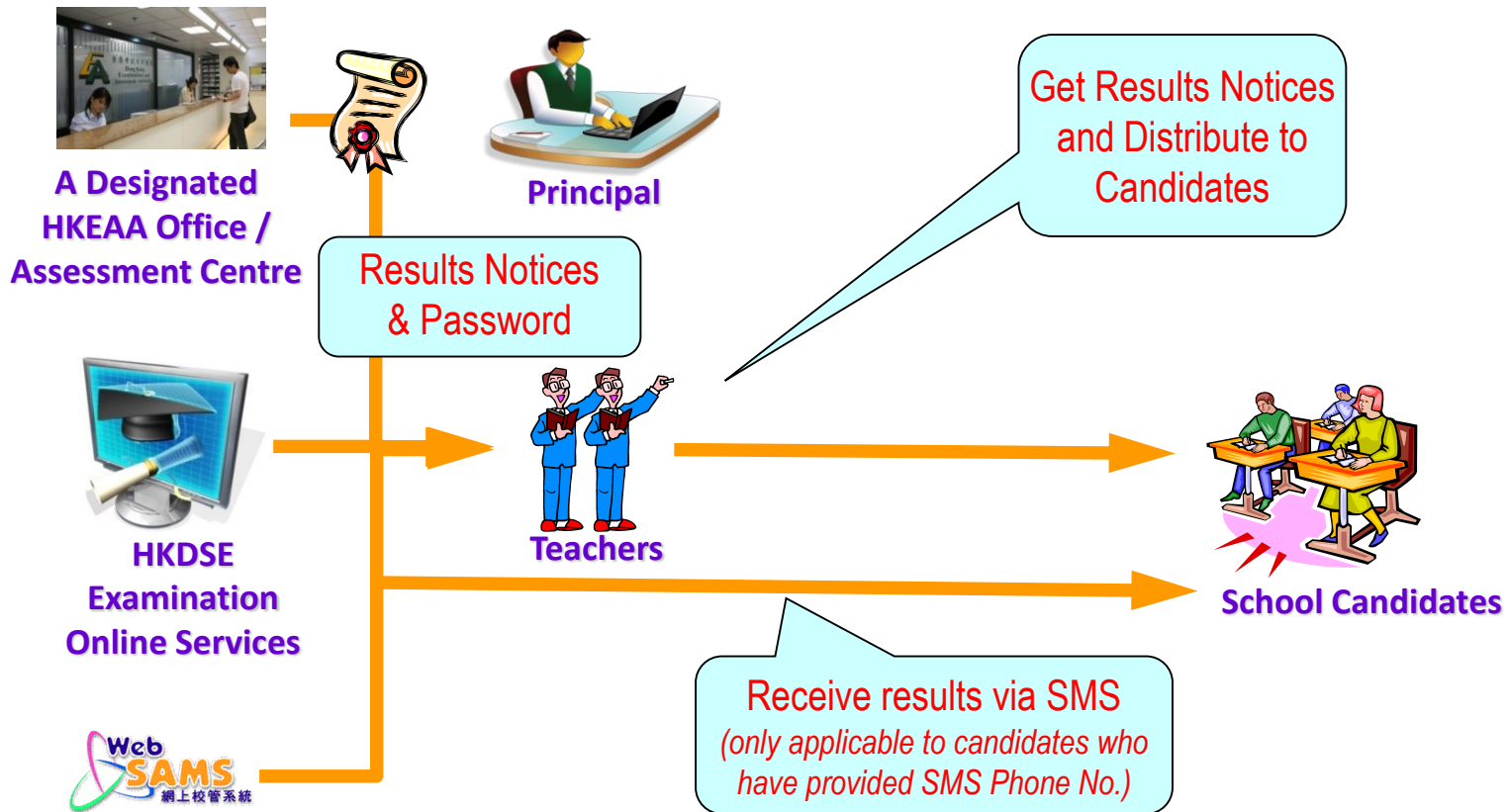
# Release of Examination Results (School Candidates)

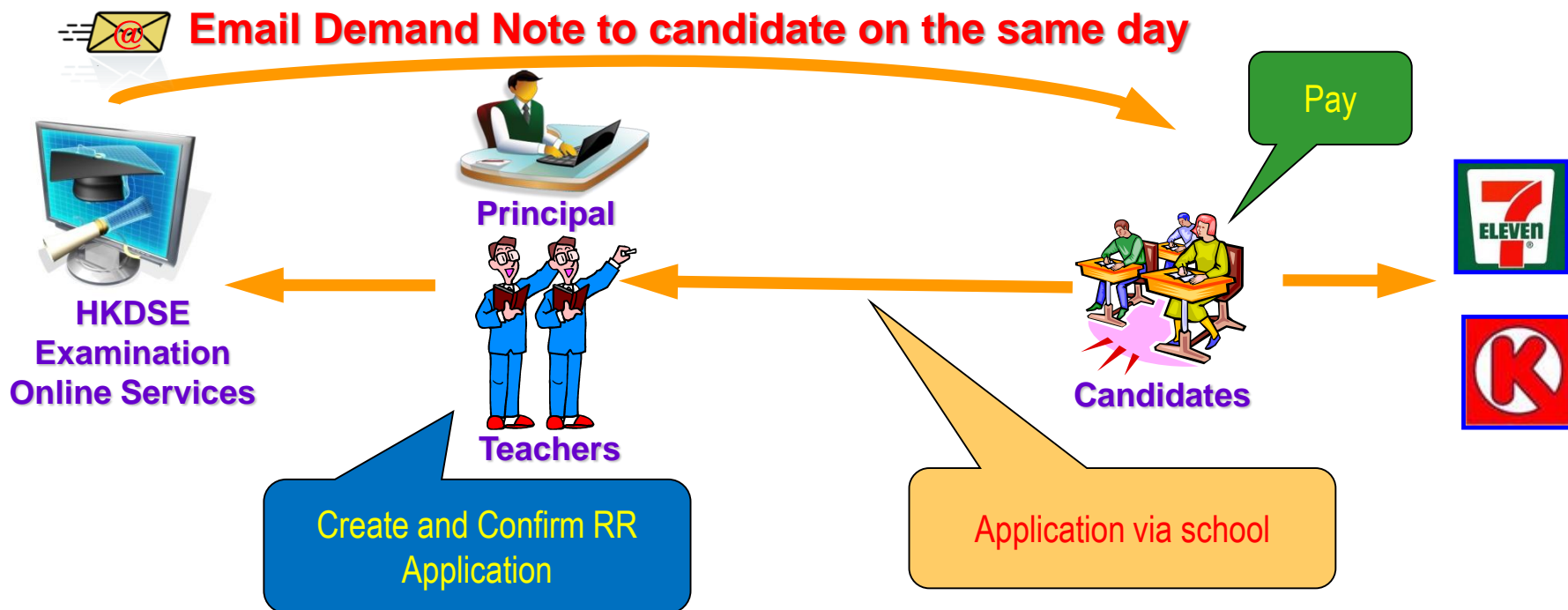

# Application Procedures

- **Application Date**  
**17 - 22 July 2024**
- Maximum no. of subjects: **FOUR** (including Category C (November 2023 series) subjects)
- Application for one or more components = **ONE** subject

# Application Procedures

- **Remarking of Chinese Language and English Language :**

- On a subject\* or component basis

*(\*Applications for remarking of the video-recorded **Speaking component** of English Language have to be made separately.)*

Application for > **FOUR subjects:**

- Submit special request with supporting documents to HKEAA within the application period (i.e. 17 - 22 July 2024)

- Other Details:

Section F of **Handbook for Candidates**



# Payment by Candidates

- Within 2 calendar days after submission by school

*Example:*

*Date of Submission: 21 July 2024*

*Payment Deadline\*: 11:59 pm, 23 July 2024*

- \* If the deadline for payment falls on a Saturday or Sunday, it will be automatically deferred to the next **Monday**
- Demand Note will be sent to the candidate by email on the same date of submission



Candidate should check the application details on the Demand Note carefully and inform school teachers for amendment (if any) before paying the fee

- Payment Method: school candidates can pay only via

# Supplementary fees under special circumstances

- Subject to the approval of HKEAA and payment of supplementary fees:

<b>Late Payment #</b>	On or before 25 July: \$295
<b>Late Application # Amendment #</b>	23 - 24 July: \$680
<b>Withdrawal of Application</b>	On or before 22 July: Refund after deduction of an administration fee of \$518 After 22 July: No refund

*# For Late Payment/ Late Application/ Amendment applications, candidates are required to visit the HKEAA Southorn Centre Office in Wan Chai to complete these applications.*

# Release of Rechecking & Remarking Results

**Date of Release: 14 August 2024 (Wed)**

**School Candidates** : receive the results notice via school and SMS message

**Private candidates** : receive results notice via surface mail and SMS message. Can also check the results by logging in the DSE Online Services

(for candidates **who have provided SMS phone numbers** during registration)

# Release of Rechecking & Remarking Results

- HKEAA will disseminate the revised results to JUPAS/other post-secondary institutions and EDB on **14 August 2024**
- Applicants with subject results upgraded may submit request for reconsideration of offer/‘better’ offer via the JUPAS online application system on **15 August 2024 (9:00 am to 6:00 pm)**

# Application for Waiving Fees



- Candidate should hand in the Fee Waiver Application Form and the original of supporting documents e.g. the document(s) of Comprehensive Social Security Assistance (CSSA) Scheme
- The HKEAA will consider the application on a case-by-case basis and will waive part of the application fee
- Candidates should pay the rechecking & remarking application fee before the payment deadline
- If the application for waiving fee is successful, refund will be made at a later stage
