
Release of Examination Results (School Candidates)

## Application for Rechecking and Remarking



### Application Procedures

- **Application Date** (for Categories A & B subjects only)  
**16 - 21 July 2025**
- May apply for rechecking and/or remarking for up to a total of four subjects

**Note:** For Category C subjects, queries / appeals for other language subjects will be handled by the respective examination providers in accordance with their standard policies and procedures. Candidates should contact the respective examination providers directly and resolve any queries on the results before 1 Mar 2025

- Application for one or more components of a subject is counted as one subject



## Application Procedures

- **Remarking of Chinese Language and English Language :**

- On a **subject\*** or **component** basis


(\*Applications for remarking of the video-recorded **Speaking component** of English Language have to be made separately.)

## Payment by Candidates

- Within **2 calendar days** after submission by school

**Example:**

**Date of Submission: 16 July**

**Payment Deadline\*: 11:59 pm, 18 July**

- \* If the deadline for payment falls on a Saturday or Sunday, it will be automatically deferred to the next Monday

- Demand Note will be sent to the candidate by email on the same date of submission




Candidate should check the application details on the Demand Note carefully and inform school teachers for amendment (if any) before paying the fee



## Release of Rechecking & Remarking Results

**Date of Release:**

**8:30am, 13 August 2025 (Wed)**



**School Candidates** : receive the results notice via school and SMS message (from 9:00am)

**Private candidates** : receive results notice via surface mail and SMS message (from 9:00am). Can also check the results by logging in the **DSE Online Services**

(for candidates who have provided SMS phone numbers during registration)

**\*The message sender displayed as '#HKEAA'**



## Release of Rechecking & Remarking Results

- HKEAA will disseminate the revised results to JUPAS/other post-secondary institutions and EDB on **13 August 2025**
- Applicants with subject results upgraded may submit request for reconsideration of offer/‘better’ offer via the JUPAS online application system on **14 August 2025 (9:00 am to 6:00 pm)**



## Application for Waiving Fees



- Candidate should hand in the Fee Waiver Application Form and the original of supporting documents e.g. the document(s) of Comprehensive Social Security Assistance (CSSA) Scheme
- The HKEAA will consider the application on a case-by-case basis
- Waive part of the application fees
- Candidates should pay the rechecking & remarking application fee before the payment deadline
- If the application for waiving fee is successful, refund will be made at a later stage



## Bad Weather Arrangements

At or before 6:00 am	Typhoon signal No. 8 or black rainstorm signal is issued.	Release of results or release of rechecking/remarking results will be <b>postponed</b> (including online results enquiry services)
At or before 1:00 pm	Typhoon signal No. 8 or black rainstorm is cancelled.	<b>Schools:</b> Can collect the results notice from the HKEAA office <b>2 hours after the signal is cancelled</b> <b>Evening schools and private candidates:</b> Can check the results via online <b>2 hours after the signal is cancelled</b> <b>SMS:</b> <b>3 hours after the signal is cancelled</b>
After 1:00 pm	Typhoon signal No. 8 or black rainstorm signal is cancelled.	Will be postponed one day to 17 Jul / 14 Aug (including online results enquiry services)
