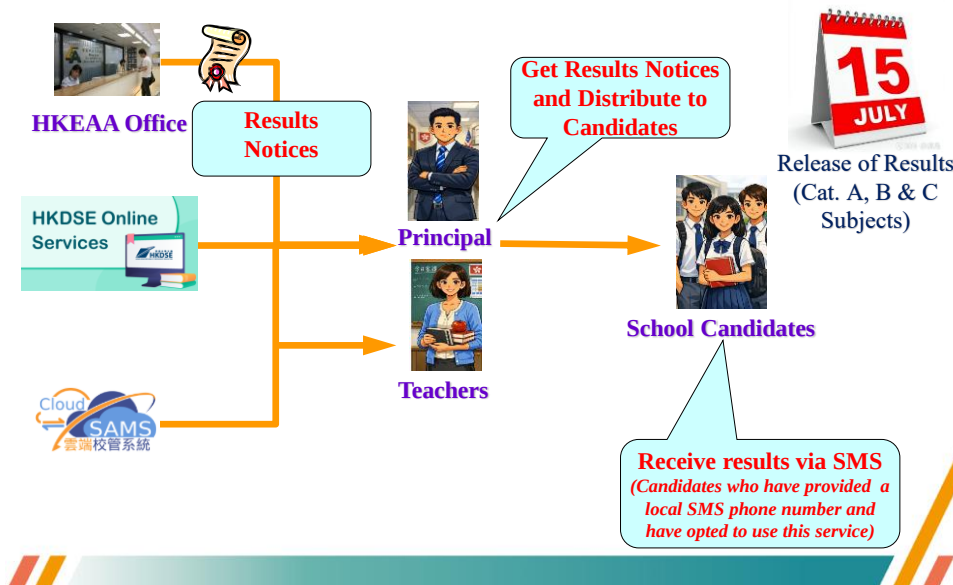

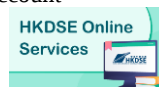

## Application for Rechecking and Remarking



### Application Procedures

**Application Period: 15 July to 20 July 2026**

#### Applicable Subjects

- For **Categories A & B subjects only**
- For Category C subjects, queries / appeals for other language subjects will be handled by the respective examination providers in accordance with their standard policies and procedures. Candidates should contact the respective examination providers directly and resolve any queries on the results **before 1 Mar 2026**.

#### Type of Application

- May apply for **rechecking** and/or **remarking** for up to a total of four subjects
- Application for one or more components of a subject is counted as one subject

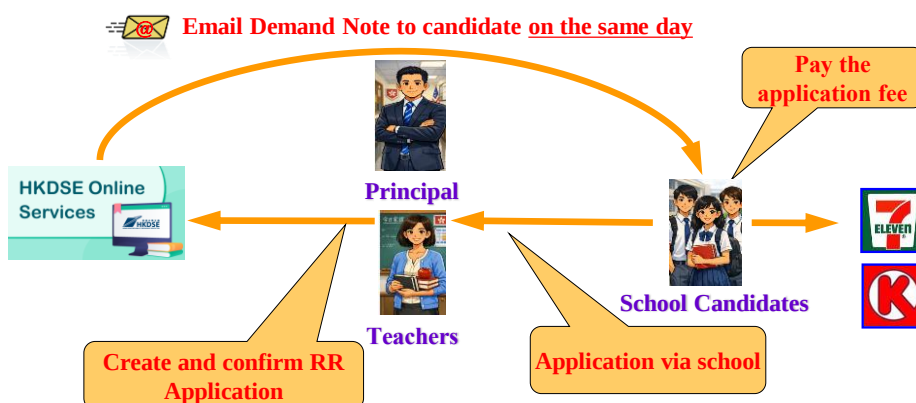


## Application Procedures

- **Remarking of Chinese Language and English Language :**
  - On a subject or component basis
  - Remarking of English Language on a subject basis includes written papers only  
(Applications for remarking of the video-recorded speaking component have to be made separately)
- **Other Details:** Please refer to Section F of Handbook for Candidates



## Schedule of Events (School Candidates)



15 Jul Release of Results → 15-20 Jul Rechecking & Remarking (RR) Application  
(Cat. A & B subjects) → Settle payment within 2 calendar days

## Payment by Candidates

- Within **2 calendar days** after submission by school

*Example:*

*Date of Submission: 15 July 2026*

*Payment Deadline\*: 11:59 pm, 17 July 2026*

- \* If the deadline for payment falls on a Saturday or Sunday, it will be automatically deferred to the next Monday

- Demand Note will be sent to the candidate by email **on the same date of submission**



Once an application is submitted, no amendments can be made via the system. Candidate should check the application details on the Demand Note carefully (including the types of applications and the chosen subjects/components) and inform school teachers for amendment (if any) before paying the fee

- Payment Method: School candidates can pay only via

- HKEAA will issue a confirmation email and Demand Note to private candidates

### Step 3 | Payment

- Online payment (by credit card)
- Download the Demand Note (7-Eleven / OK convenience stores)

## Release of Rechecking & Remarking Results

- HKEAA will disseminate the revised results to JUPAS/other post-secondary institutions and EDB on **12 August 2026**
- Applicants with subject results upgraded may submit request for reconsideration of offer/‘better’ offer via the JUPAS online application system on **13 August 2026 (9:00 am to 5:00 pm)**



## Application for Waiving Part of the Fees

- Candidate should hand in the Fee Waiver Application Form and the original of supporting documents\* e.g. the document(s) of Comprehensive Social Security Assistance (CSSA) Scheme
- The HKEAA will consider the application on a case-by-case basis
- Waive part of the application fees
- Candidates should pay the rechecking & remarking application fee before the payment deadline
- If the application for waiving fee is successful, refund will be made at a later stage



\* Note: Candidates must submit the application in person at the HKEAA Southorn Centre office from 15 to 20 July 2026, during office hours, Monday to Friday
